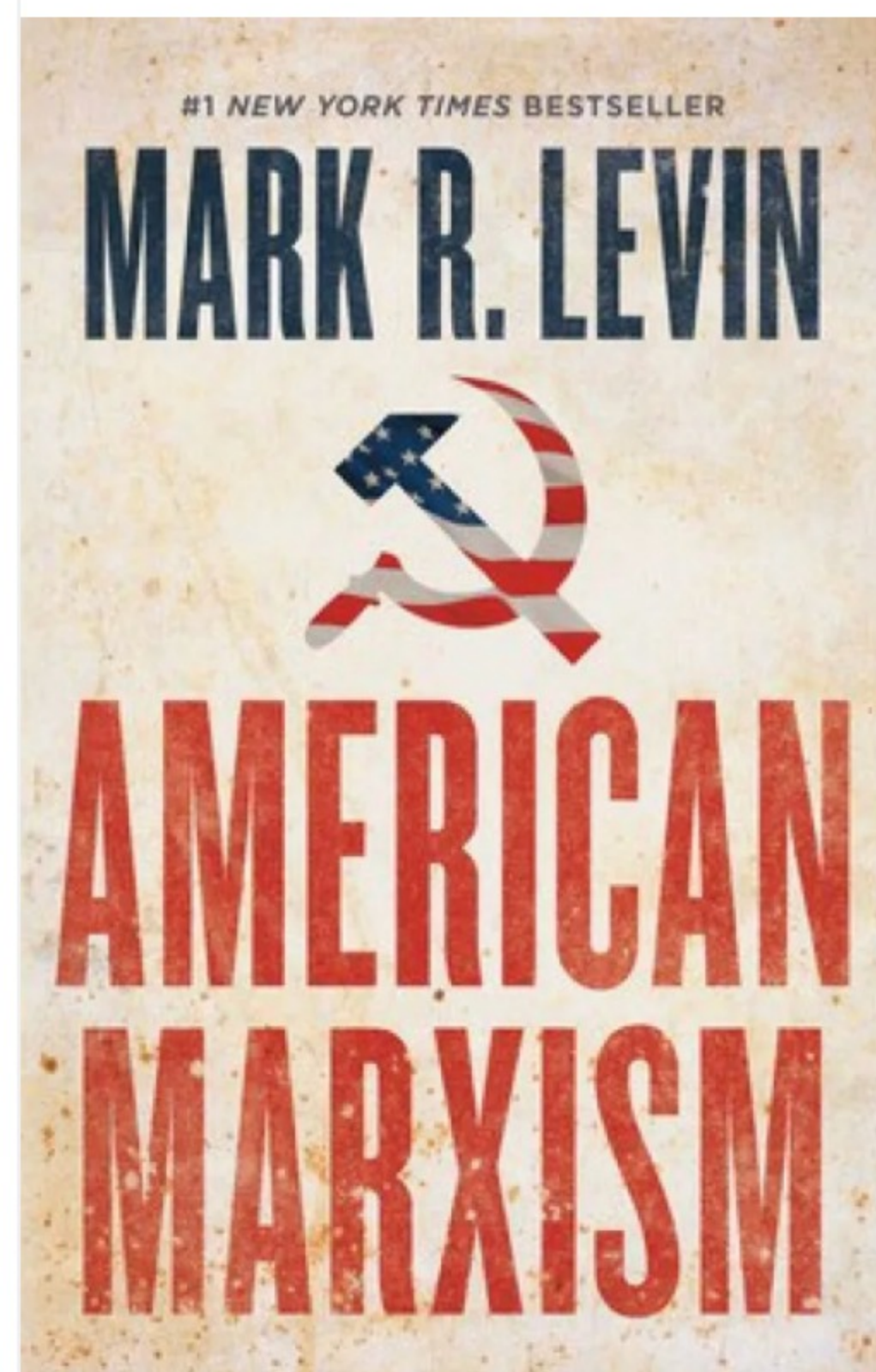

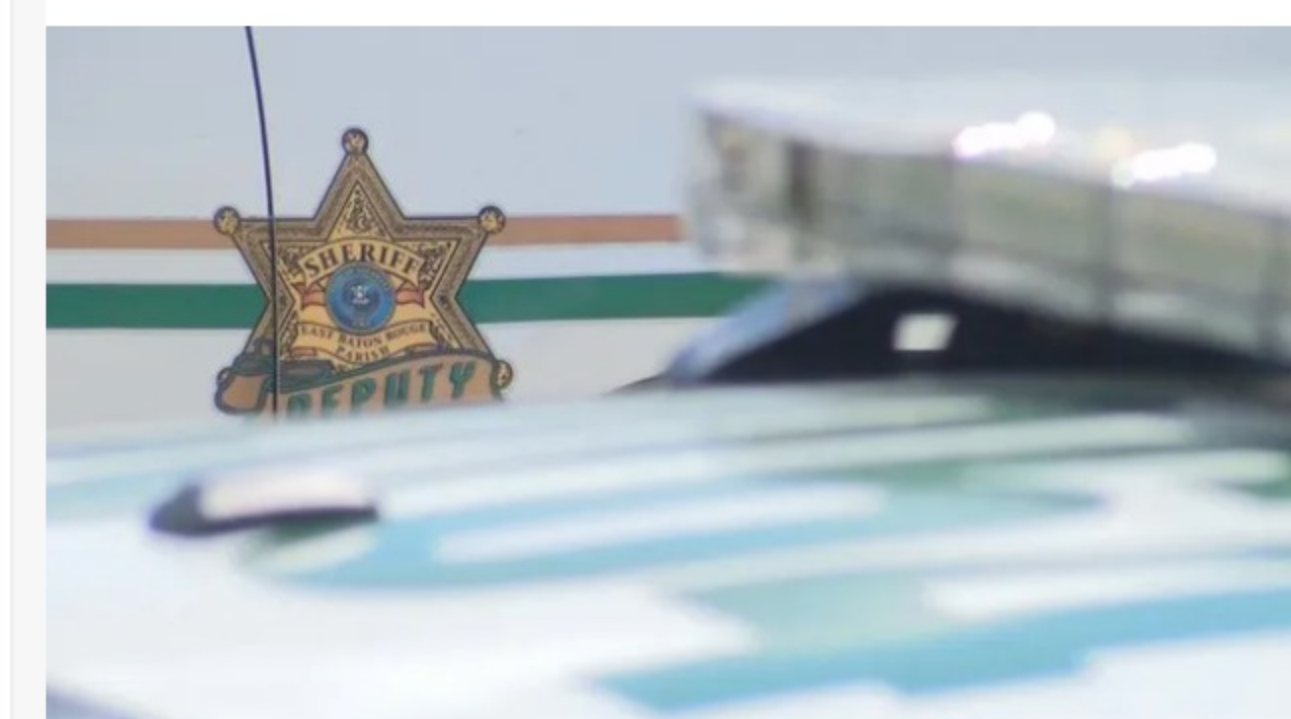

The "they" Travis was referring to were Pye and his sister, Carolyn Dixon.



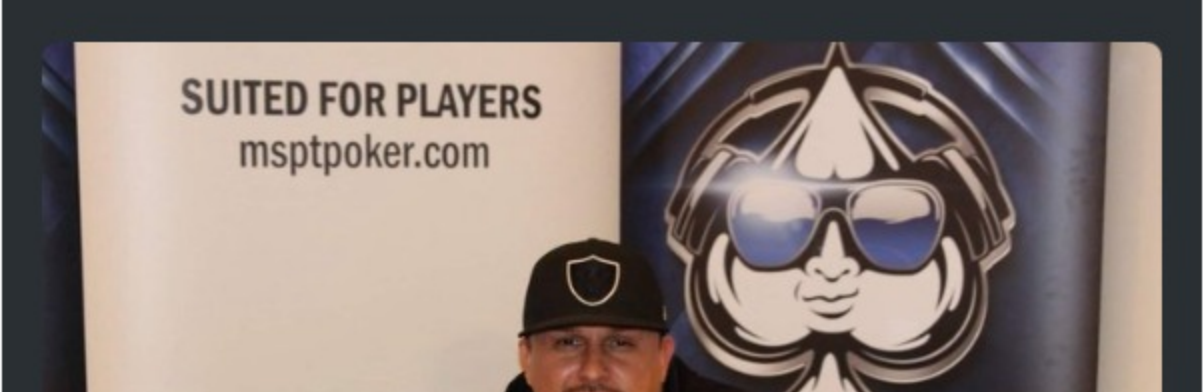
